In the event Seller commences any action, or otherwise seeks to enforce this agreement against Buyer or any Guarantor, Buyer shall pay all the collection agent fees and expenses, reasonable attorney(s) fees, court and other expenses incurred by Seller, whether or not suit is filed. This agreement is not transferable or assignable without prior written consent of Seller. This agreement shall become effective upon acceptance by Seller. Seller reserves the right to modify, curtail, or eliminate credit availability to the Buyer within its sole discretion. Buyer agrees that all sales shall be governed by Seller's standard terms and conditions of sale and posted on Seller's internet site at <a href="http://www.vericomsolutions.com">www.vericomsolutions.com</a>, unless Seller and Buyer have executed a separate agreement which specifically supersedes and replaces those terms and conditions. This agreement and all other agreements with Seller including but not limited to, the standard terms and conditions of sale, are considered to be single integrated agreement. Buyer further acknowledges that the appropriate forum for litigation with respect to enforcement of this credit application and any agreement for sale of goods shall be in a court of competent jurisdiction in Knox County, Tennessee. Notwithstanding the place of business of Buyer or the place of execution of this credit application and agreement, the laws of the State of Tennessee shall control the construction, interpretation and enforcement of this credit application and agreement and all matters related to this credit application and agreement, without application or reference to conflict of laws provisions. Each party hereby waives trial by jury in any action, proceeding, claim, or counterclaim brought by either party in connection with any matter arising out of or in any way connected with this credit application and any agreement underunder.
